Community Connections

Connecticut Counseling Centers, Inc. has always been involved in the communities it serves, sharing knowledge and experience in treating substance use and mental health disorders and collaborating with other providers to develop community focused solutions to addiction and mental health issues. Throughout the year, the staff represented the organization at a variety of community, state and national collaborations, associations, and boards. Below are highlighted community connection events that Connecticut Counseling Centers, Inc. staff have hosted or participated in.

South Main Street Coalition (Norwalk)

Connecticut Counseling Centers is a proud member of the "South Main Street Coalition." It is comprised of local leaders from the Open Door Shelter, Norwalk Hospital and Norwalk Police Department, Community Care Team, and the Norwalk Community Health Center. The group addresses homelessness, crime problems, and illicit drug use in the South Main Street area of South Norwalk. CCC is an integral partner in providing mental health and substance abuse treatment for citizens of South



Main Street area. In the year since its inception, the Coalition has grown to over 20 different agencies ranging from Bridgeport to Stamford. It was founded by Jeff Greenblatt, Program Director of CCC Norwalk Clinic, and Open Door employees, Frank Concepcion and Sam Williams. On September 17th, 2021 the coalition organized and held a recovery fair. Agencies representing the Coalition joined together for a day of food, music and recovery. Over 15 tables were set up and the citizens of the neighborhood joined the event for information on recovery and treatment. Speakers with lived experiences shared their messages of strength and hope.

Overdose Awareness Day at Hubbard Park

The Meriden Opioid Treatment Program (OTP) Clinic had the opportunity to attend this event on August 28, 2021 to celebrate recovery and promote overdose awareness. The event was organized by Hartford Healthcare and the Meriden Health Department. Our full time nurse, Susan Perry, and Clinical Team Leader, Josh Noffsinger operated the agency's informational table, allowing for the opportunity to engage both the public and other healthcare providers in discussion, provide education, and hear from family members who have experienced overdose deaths in their family, as well as how to help family members who are currently battling their own addiction issues. Overall, they spoke with about 50 individuals from the community.

Many of those whom Susan and Josh spoke with were not aware that a new Opioid Treatment Program that provides access to methadone had opened in Meriden, allowing them to provide contact information and promote word-of-mouth exposure to the community about their presence. All of those whom they informed about the clinic's services expressed that they felt encouraged that the clinic had opened and felt it was long overdue for a community that had been battling opiate addiction for a long time.



Susan and Josh were also able to make some crucial connections with the PROUD Program, Wheeler Clinic, ALANON, Rushford, Meriden Women & Families Center (WFC), and the Department of Health and Human Services in Meriden, among others.

Meriden Evangelistic and Community Event

The Meriden OTP Clinic was invited by the Meriden Women & Families Center (WFC) to participate in their co-sponsored Evangelistic and Community Networking Event on June 25, 2022 for providers and the community to promote local health and human services, as well as allow providers to connect with one another. WFC staff made a connection with Program Director Josh Noffsinger at the Overdose Awareness Event previously, resulting in an invitation to participate. A local church (Iglesia de Dios Pentecostal M.I. de Meriden) hosted the event along with the WFC, where there was live music, free food, COVID-19 vaccines provided by Griffin Hospital, and multiple health and human service vendors. Joining Josh were our counselors Karen Graham and Aurelia Mushrall.

Approximately 40 people spoke with our staff and received business cards, informational pamphlets, and CCC pens and hand sanitizer. CCC Staff made connections and gathered resource information for our patients from Hartford Healthcare Bright Start program, American Job Center, Chrysalis Domestic Violence Services, and strengthened connection to the WFC, who provides a number of important services that could assist our population. WFC plans on making this an annual event and invited CCC to attend next year.

In September of 2021 the Midland Road (Waterbury) facility hosted an overdose awareness event. During the event, educational materials and information regarding opioid misuse and overdose were provided to CCC patients and the community.



CCC Hosts a Connecticut Department of Public Health Covid-19 Vaccination Clinic (Waterbury)

The Brookside Clinic partnered with the Connecticut Department of Public Health to facilitate a three day Covid-19 Vaccination Clinic at the Brookside clinic on September 8, 9, 10, 2021. A total of 29 vaccinations were administered to Connecticut Counseling Centers, Inc. patients.

Facility Improvements: Norwalk Clinic

During the past year, the Norwalk facility has been renovated to update and brighten the environment. Improvements include a new aesthetically pleasing color pallet throughout the facility and the installation of 5,000 sf of LVT flooring which was generously donated by Harlan Stone, the CEO of HMTX, a global flooring company located in Norwalk. The lobby, hallways, and group/meeting rooms are now modernized with the wood-inspired linoleum flooring, while the rest of the clinic has new carpeting. The IOP and MARS room, as well as some of our staff offices have also received makeovers with new office furniture. Patients, visitors, and staff have remarked that the atmosphere is now much more appealing and pleasant.





Court Support Services Division (CSSD)

We completed the 15th contract year with the State of Connecticut Judicial Branch Court Support Services Division (CSSD). CSSD contracts with CCC to provide adult behavioral health services. Connecticut Counseling Centers has continually met or exceeded benchmark outcome measures which has resulted in the continual expansion of patient services.

CCC is contracted to provide Adult Probation, Bail Services, and Family Services with the following services: Integrated Mental Health and Substance Abuse Assessments, Supervised Diversionary Program Evaluations and Reporting, Substance Abuse Group Services, Mental Health Group Services, Gender Specific Services, Intensive Outpatient Treatment Services, Individual Sessions, and Medication Evaluation and Management. These services are provided at five of our facilities located in Norwalk, Meriden, Stamford and Waterbury. The current three year contract with two one year extensions ended June 30, 2022.

CCC applied for and was awarded the CSSD contracts for FY 2023 – FY 2027 for all clinic locations; Danbury, Meriden, Norwalk, Stamford, and Waterbury. These contract awards were based in part on exemplary past performance. Congratulations to CCC staff involved with the delivery of CSSD services for a job well done!

CSSD Services Division Statistics

During the past fiscal year, CCC received 1052 CSSD referrals for assessment and treatment of mental health and substance use disorders. This represents a 5.7% increase compared to the previous fiscal year.

CSSD Performance Goals

Connecticut Counseling Centers, Inc. met or exceeded all CSSD/CDCS performance goals once again this year. During the past year all Court Support Service Division (CSSD) contracted CCC clinics were designated as "level one" rated facilities which is the highest rating given by CSSD!

Effective treatment for substance use disorders and mental health disorders reduces relapse and associated criminal activity. The State of Connecticut Judicial Branch tracks recidivism rates (return to criminal activity) for those referred to treatment by CSSD. For those referred by CSSD who successfully complete treatment, the average state-wide rate of recidivism is 23% (compared to over 70% for those who do not complete treatment). During the same time period, the recidivism rate for those completing treatment at Connecticut Counseling Centers was:

- > 13% at the Norwalk facility
- > 16% at our Stamford facility
- 22% at our Meriden facility
- 23% at the Waterbury facilities

Offenders who receive proper treatment services at CCC are significantly less likely to be rearrested!

Innovative CCC Programs

CCC has always provided state of the art evidence based treatment services. CCC has also been recognized as a leader and innovator in the field of Behavioral Healthcare. The following initiatives have received state and national recognition.

Peer Recovery Support Programs

Connecticut Counseling Centers, Inc. is proud of its cutting edge work in developing and implementing innovative peer support services. These include the following:

- ✓ Recovery Coach for Waterbury Opioid Treatment Programs: A DMHAS funded Recovery Coach who has lived experiences with both opioid dependence and recovery with Medication Assisted Treatment provides recovery supports for patients in our two Waterbury Opioid Treatment Programs (OTP).
- ✓ Bridge to Recovery (BTR) program: This program offers any OTP patient who is in need of extra support a Peer Mentor, who is an OTP patient in long-term recovery and trained as an addiction specialist, to work with them offering individual peer counseling and support services. BTR services were suspended due to the Covid-19 pandemic. Additional Peer mentors are currently in training and we are hoping to restart the program in 2023.
- ✓ M.A.R.S., (Medication Assisted Recovery Support) program: The Norwalk Clinic also offers the M.A.R.S. program. The M.A.R.S. program offers OTP patients peer led informational and spiritual groups, social groups that support recovery, and other peer activities that encourage and promote living a healthy lifestyle.

BIRTH Program

CCC's "Born in Recovery through Healthcare (BIRTH)
Program" is a specialized treatment track for pregnant
women in one of the five Opioid Treatment Programs.
This year was another successful one for our BIRTH
Program as evidenced by 22 healthy births. The
primary goal of the BIRTH program is healthy birth



outcomes. This is accomplished by providing the pregnant patient with wraparound clinical, case management, and support services. The staff at CCC recognizes and understands the complex needs of our pregnant clients, and has employed evidenced based treatment models that address their multiple issues. Research has also identified that healthy support systems are vital to promote better outcomes for mother and infant and this has been an area of focus for CCC Staff as well.

The primary goal of the BIRTH program is to produce healthy birth outcomes. This includes decreasing the incidence of substance abuse during pregnancy, increasing the gestational age of the pregnancy to full term or near full term, and decreasing the incidence of low birth weight babies. These goals are reached through the provision of intensive and specialized counseling and case management services in collaboration with the patient's primary healthcare providers and local hospitals. The key to the success of the program is the individualized case management services provided at CCC during both prenatal and postpartum care.

CT CADAC Training Program

Established in January 1995, the Connecticut Certified Alcohol and Drug Abuse Counselor Training Program (CT CADAC Training Program) is a comprehensive addiction counselor training program. The training program is designed to prepare both the professional counselor as well as the non-professional for a career in treating substance use disorders. The program provides the student with the knowledge and skills necessary to provide treatment services and prepares them for certification and licensure. The CT CADAC Training Program curriculum satisfies the Connecticut Department of Public Health and the Connecticut Certification Board training requirements for certification or licensure as an Alcohol and Drug Abuse Counselor.

The training program transitioned to a hybrid model utilizing the Zoom platform for the majority of classes. During the past fiscal year the training program provided 39 Zoom classes serving 22 students. The training program has direct billing contracts with Liberation Programs, Inc. and Recovery Network of Programs, Inc. to provide training for their counselors and peer support staff. During the past year six students from these two organizations received training.

Addiction Medicine Clinical Rotations

Dr. Kraus, Chief Medical Officer of CCC, has been working with Yale University Medical School to resume an elective rotation in Addiction Medicine for Yale Medical School students, Interns and Residents in the General Internal Medicine Residency Program. The Addiction Medicine Rotation, which was on hold during the pandemic, will resume in the fall of 2022.

Dr. Kraus has continued to work with COPE to support Medical School faculties in their efforts to develop the knowledge and skills students need to address and to treat alcohol, tobacco, opiate, and other drug disorders. This endeavor will strengthen CCC's efforts to participate in the training of medical students in substance use disorders.

Dr. Kraus is a lecturer for the Providers Clinical Support System (PCSS) which is a national virtual training and clinical mentoring project developed and implemented by SAMHSA. During the past fiscal year Dr. Kraus presented "Faced with a raging opioid epidemic, why has organized medicine not been more successful in educating colleagues and students to better diagnose opiate use disorder."

Santa Brings Cheer to Norwalk Children



Unfortunately the annual tradition of a children's Christmas party for the children of our Norwalk facility patients was again postponed due to the Covid-19 pandemic. That did not stop Santa from delivering presents to the kids in need! The Holiday gifts were once again provided by Inspirica of Stamford. The Program Director, Jeffrey Greenblatt was responsible for picking up the gifts and making sure the children still received gifts in spite of the pandemic.

Inspirica makes sure children infected and affected by HIV/AIDS receive a special Christmas every year. Gifts were provided to the children of patients who are struggling financially. The recipients and the program are very grateful for the love and support they receive every year from agencies and volunteers in the community. We're hoping that its business as usual for next year's Christmas Party!
